The following current or former employees, their spouses and children are eligible to request Confidential Status pursuant to §119.071(4)(d), F. S.

- Law enforcement personnel, including correctional and correctional probation officers.
- Department of Children and Family Services personnel whose duties include the investigation of abuse, neglect, exploitation, fraud, theft, or other criminal activities.
- Department of Health personnel whose duties are to support the investigation of child abuse or neglect.
- Department of Revenue or local governments personnel whose responsibilities include revenue collection and enforcement or child support enforcement.
- Firefighters who hold a certificate of compliance issued by the Division of State Fire Marshal of the Department of Financial Services.
- Justices of the Supreme Court, District Court of Appeal Judges, Circuit Court Judges, and County Court Judges.
- State Attorneys, Assistant State Attorneys, Statewide Prosecutors, or Assistant Statewide Prosecutors.
- Human resource, labor relations, or employee relations directors, assistant directors, managers, or assistant managers of any local government agency or water management district whose duties include hiring and firing employees, labor contract negotiation, administration, or other personnel-related duties.
- United States Attorneys and Assistant United States Attorneys.
- Judges of the U.S. Courts of Appeal, U.S. District Judges, and U.S. Magistrates.
- Code Enforcement Officers.
- Guardian ad litem as defined in §39.820, F.S.
- Juvenile Probation officers and supervisors, Detention superintendents and assistant superintendents, Juvenile Detention officers and supervisors, Department of Juvenile Justice house parents and house parent supervisors, group treatment leaders and supervisors, rehabilitation therapists and social services counselors.
