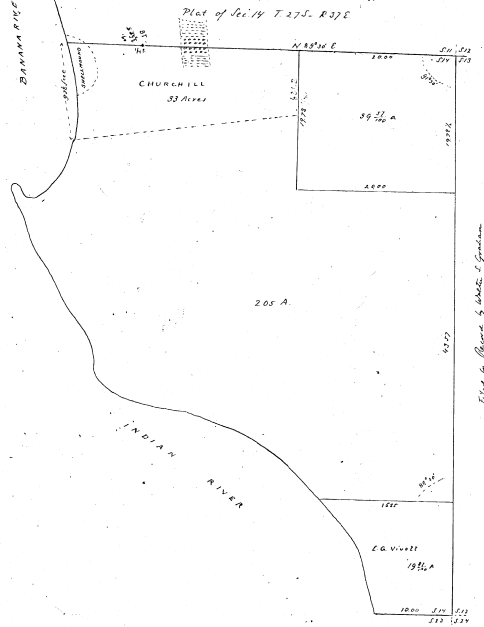


For Replat see P. 2, pgs 1, 10

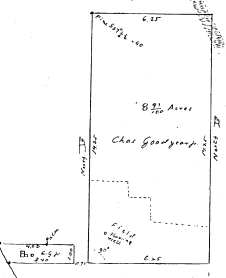

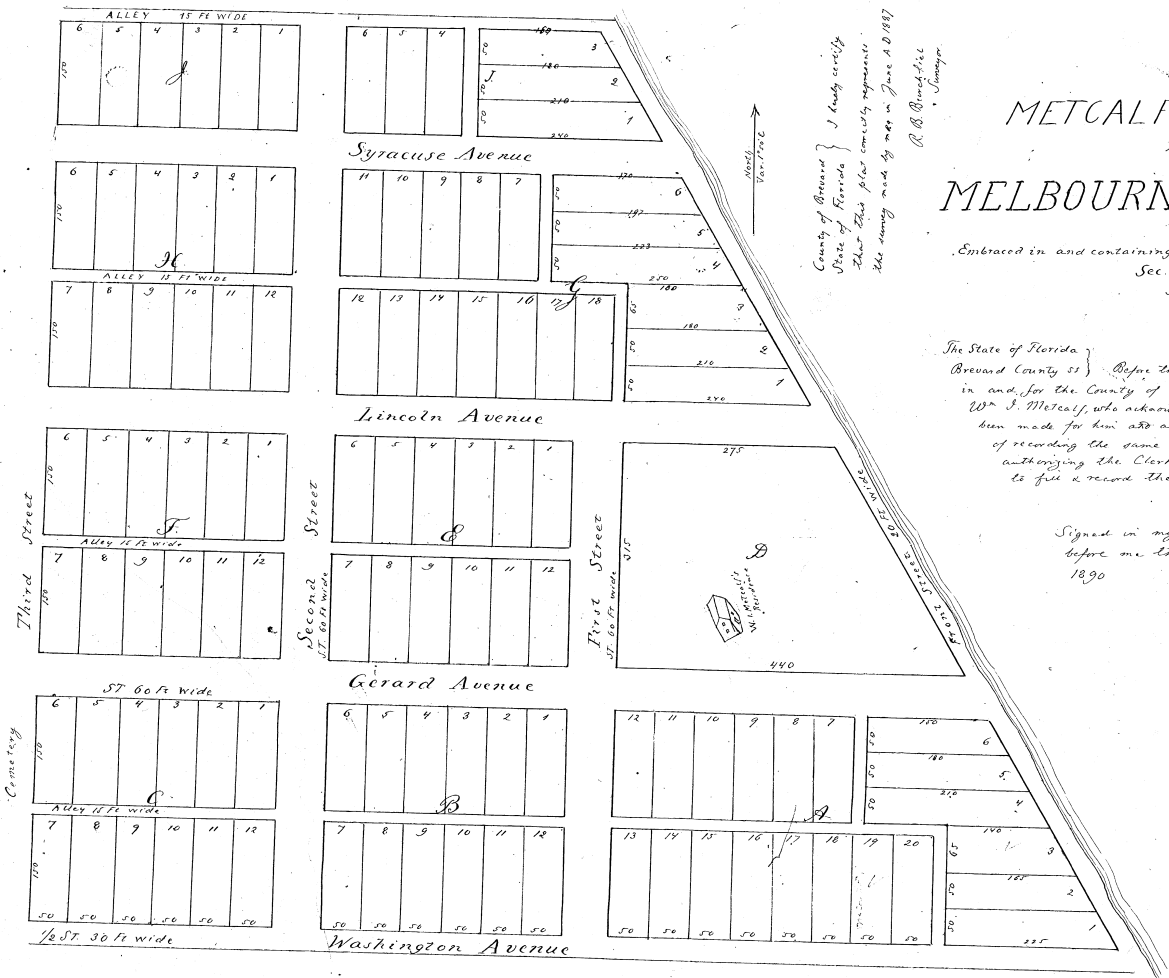
