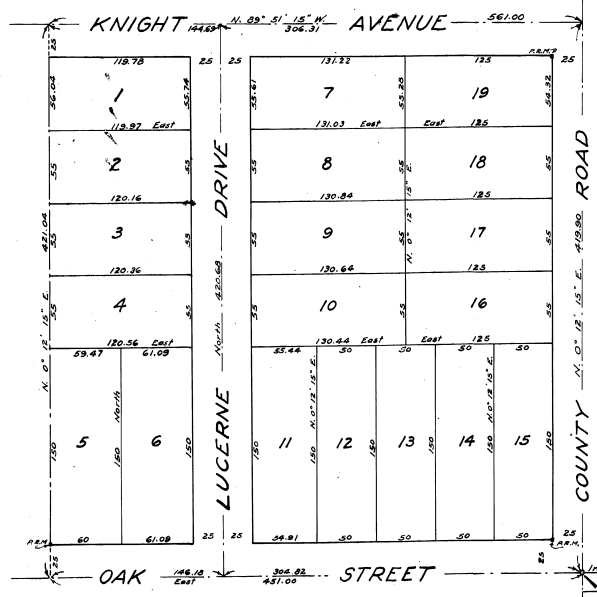
E.C. JOHNSON'S SUBDIVISION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, E.C. Johnson and Fannie Johnson, his wife, have caused the lands shown upon and described in the caption of the annexed plat to be surveyed and subdivided and plotted under the name of E.C. Johnson's Subdivision.

And we do severally and jointly dedicate to the perpetual use of public the Streets, Avenues, Drives and Roads shown on said plat and contained within the bounds thereof, reserving only for ourselves, our heirs, successors, or assigns the reversion or reversions thereof if ever discontinued by law.

WHEREFORE, it is presented that the said plat be admitted to record in the office of the Clerk of the Circuit Court for Brevard County, Florida to be recorded in accordance with the laws of the said State.

Johnson on a separate and private examination taken and made by and before me, and separately and apart from her said husband, did acknowledge that she made herself a party to the said instrument for the purpose of renouncing, relinquishing and conveying all her right, title and interest, whether of dower or of separate property, statutory or equitable, in and to the lands therein described, and that she executed said instrument freely and voluntarily, and without any constraint, fear, apprehension or compulsion of or from her said husband.
