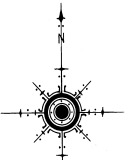
SECTION A AND PART OF SECTION B

A SUBDIVISION OF THE SOUTH PART OF
U.S. LOTS 5 & 6 SECTION 25, T22S, R37E,
BREVARD COUNTY, FLORIDA, AS FOLLOWS:

Begin at the S.E. corner of U.S. Lot 5 Sec. 25 aforesaid at the N.W.M. of the Atlantic ocean
thence West along south sdy. Lot 5 2622.08 ft. more or less to the S.W. corner U.S. Lot 5, thence
N 0° 39' 00" W, 910.87 ft. along W sdy. U.S. Lot 5, thence East 1511.72 ft., thence N 01° 25' 30" W 352.22
ft. to the N.W.M. of the Atlantic ocean, thence South easterly along the N.W.M. of the Atlantic
ocean to R.O.B. also begin at S.W. corner of U.S. Lot 6 at the low water mark on the Banana
river thence East 1344.68 ft. more or less to the S.E. corner of U.S. Lot 6 Sec. 25 aforesaid
thence N 0° 39' 00" W, 910.87 ft. along the East sdy. of Lot 6 thence W 116.3 ft., thence
N 91° 45' W 75.38 ft., thence S 80° 15' W 252.5 ft. more or less to the low water mark of the
Banana River thence South easterly meandering the low water mark of the
Banana River to the P.O.B.

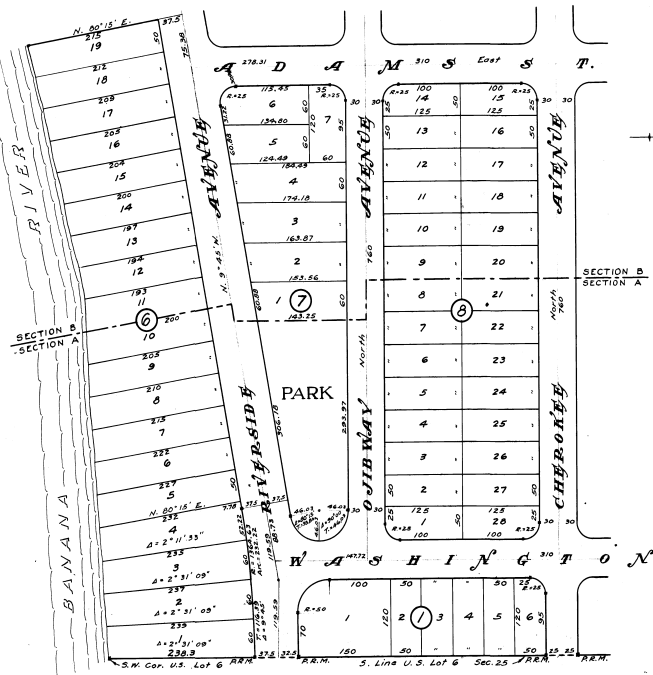

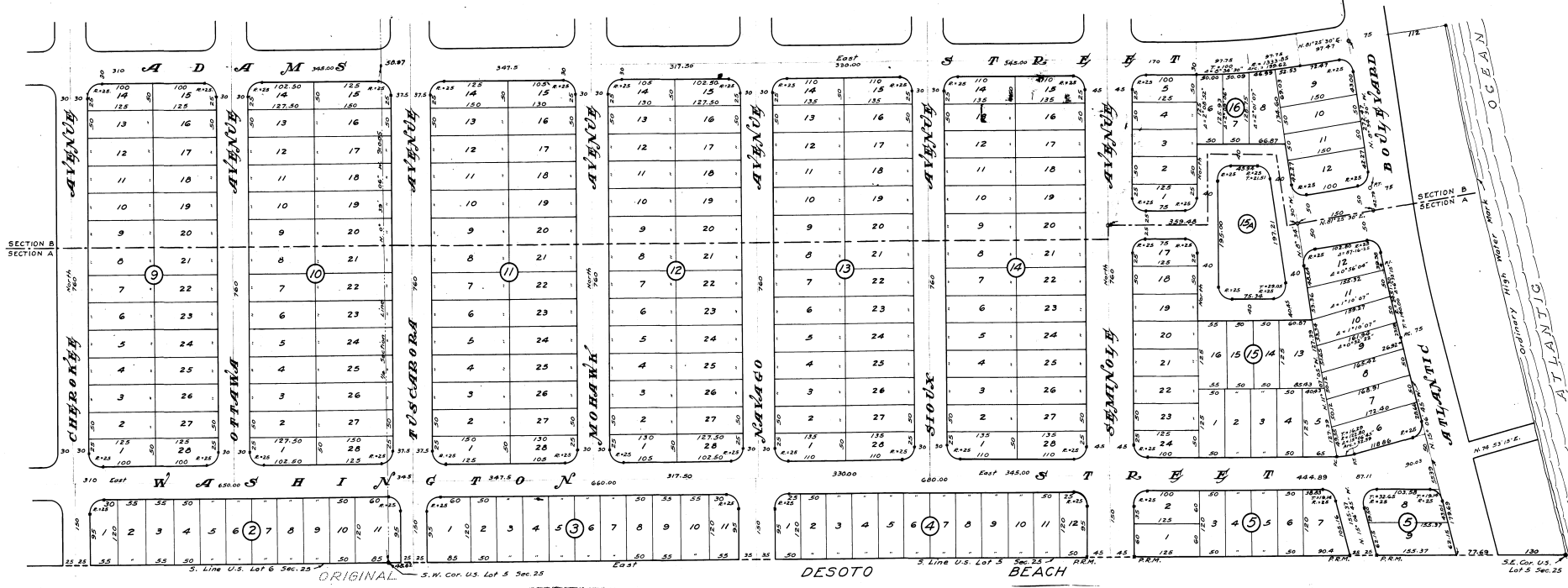
