IN WITNESS WHEREOF the said Helen D. Michel, widow, has hereunto set her hand and seal, this 11th day of March, A.D. 1929.

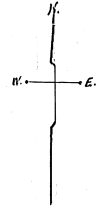
RESUBDIVISION OF RIVER VIEW

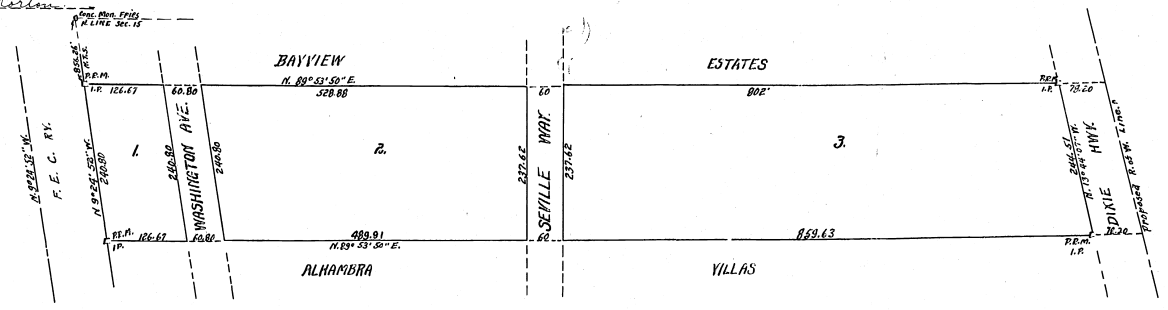
