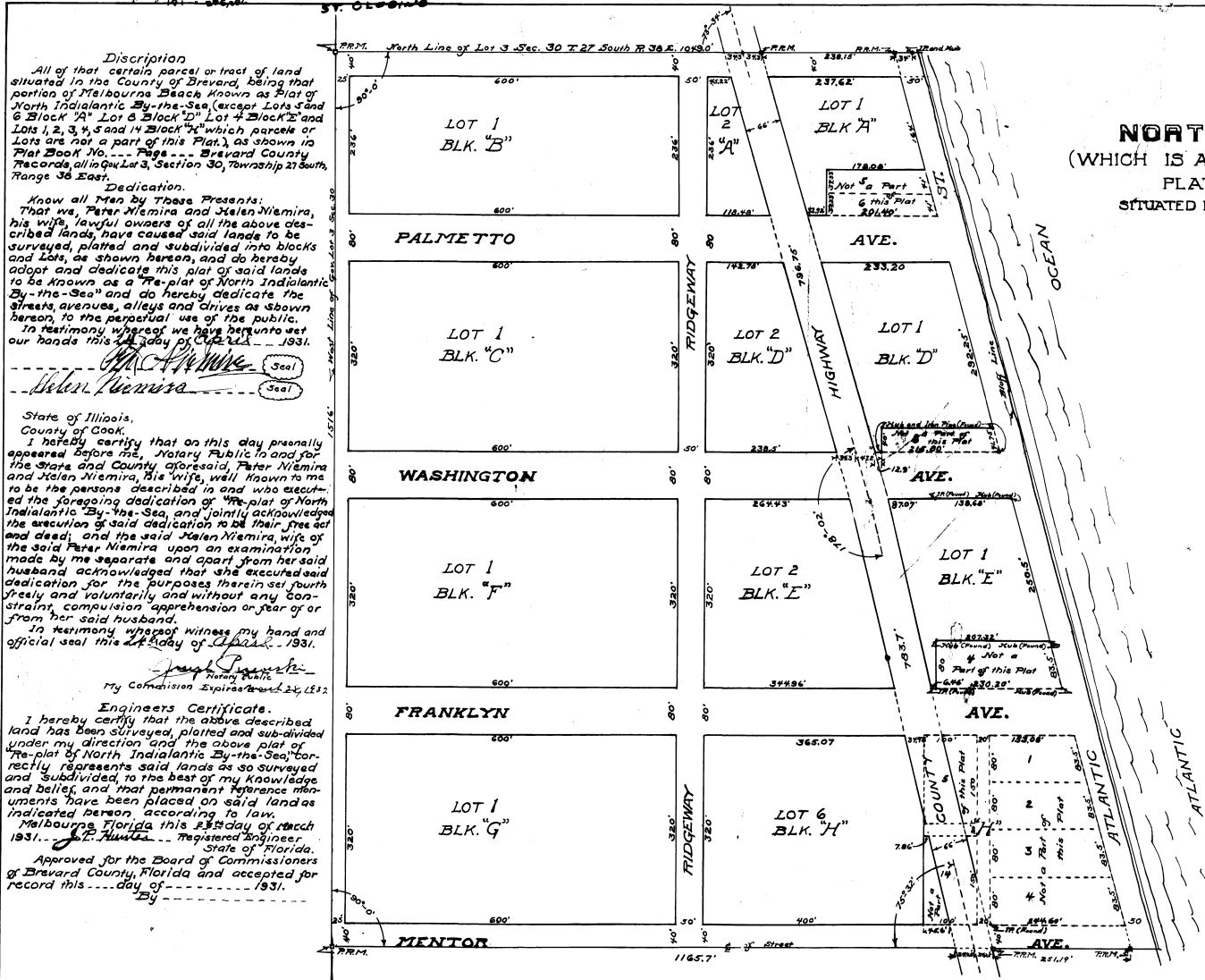
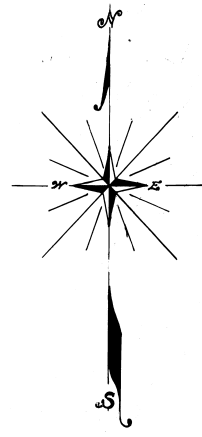

Brevard County Records, all in Gov. Lot 3, Section 30, Township 27 South, Range 38 East.
