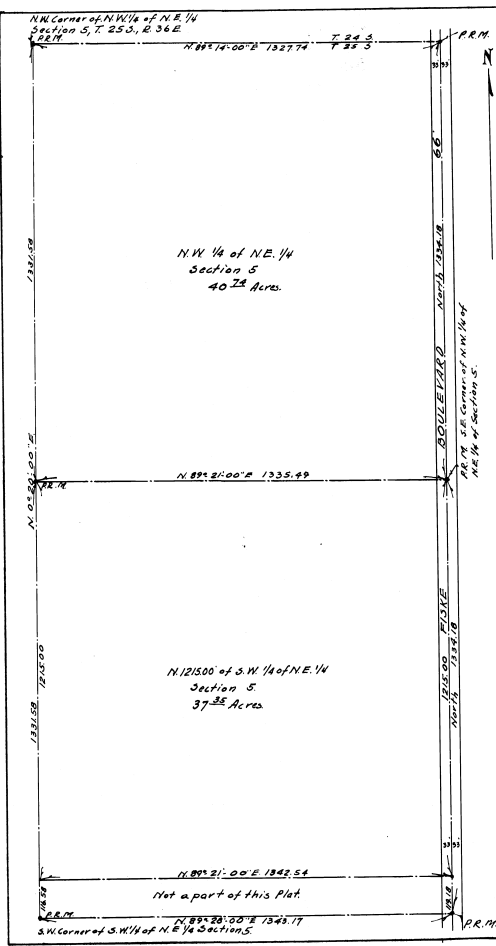

KNOW ALL MEN BY THESE PRESENTS: That we, Fred D. Baldwin and John W.
