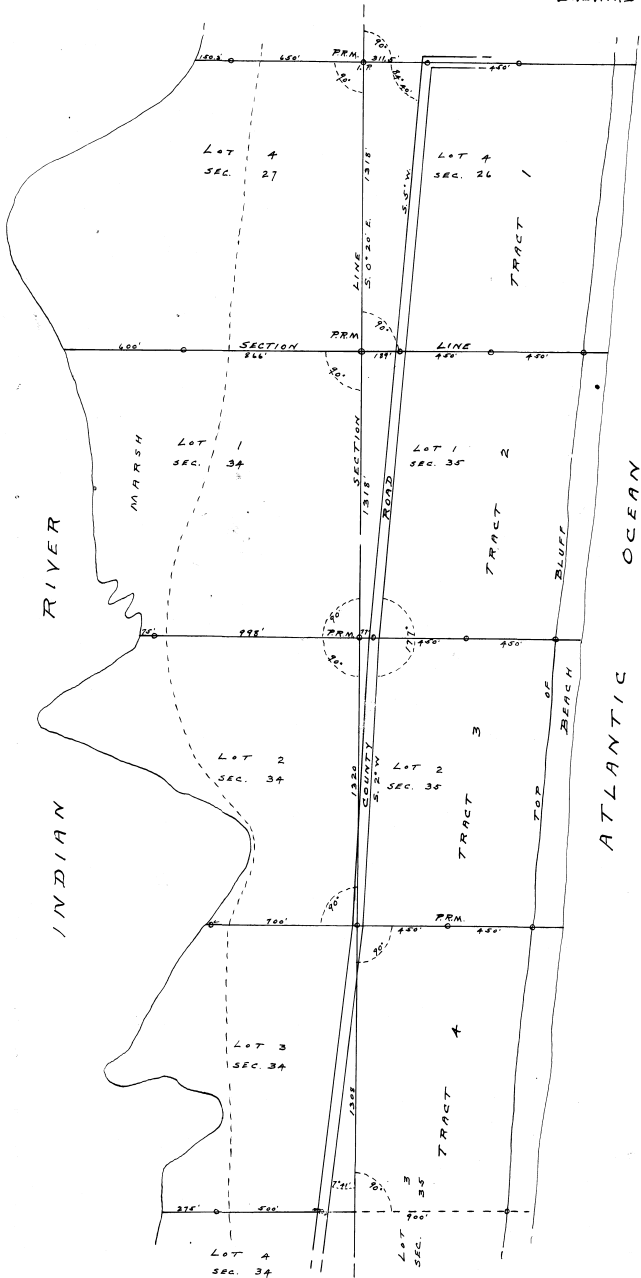

RANGE 37 E. BREVARD COUNTY, FLORIDA, AND DO HEREBY DEDICATE TO THE PERPETUAL USE OF THE PUBLIC THE ROADS AS SHOWN THEREON FOR THE USES AND PURPOSES THEREON DESCRIBED, RESERVING ONLY TO THEMSELVES, THEIR HEIRS, SUCCESSORS OR ASSIGNS, THE REVERSION OR REVERSIONS THEREOF, IF EVER DISCONTINUED BY LAW OR ABANDONED BY THE PUBLIC.
