Begin on the south line of Section 10, T. 24 S., R. 36 E. at a point which is 330.06' west of the southeast corner thereof; thence N. 0° 25' 00" W. 668.50' to a point; thence N. 89° 59' 00" W. 378.10' to a point; thence due south 668.50' to a point on the south line of said Section 10; thence S. 89° 59' 00" E. 385.52' to the point of beginning.
