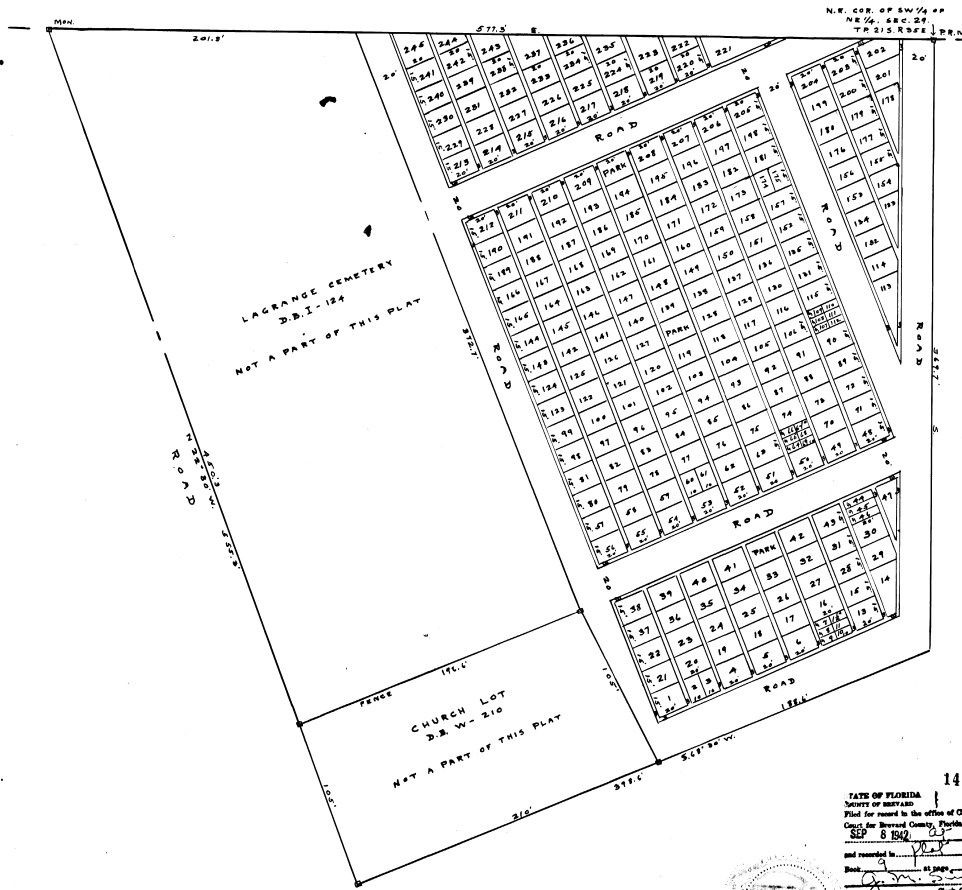

DESCRIPTION

BEGIN AT THE N.E. CORNER OF THE SW 1/4 OF THE NE 1/4 OF SEC. 29, T. 21 S., R. 25 E. THENCE RUN SOUTH 339.7 FT. TO A MONUMENT, THENCE S. 87° 30' W. 398.8 FT. TO A MONUMENT ON THE EAST SIDE OF THE TITUSVILLE & ENTERPRISE ROAD AT THE S. V. CORNER OF THE CHURCH LOT, THENCE N. 22° 30' W. ON THE EAST SIDE OF SAID ROAD 359.5 FT. TO A MONUMENT, THENCE EAST 377.5 FT. TO THE POINT OF BEGINNING, EXCEPTING THEREFROM THE ORIGINAL CEMETERY LOT AS DESCRIBED IN DEED BOOK I PAGE 124 AND THE CHURCH LOT AS DESCRIBED IN DEED BOOK W PAGE 210, RECORDS OF BREVARD CO., FLA., CONTAINING 2.5 ACRES, MORE OR LESS.
