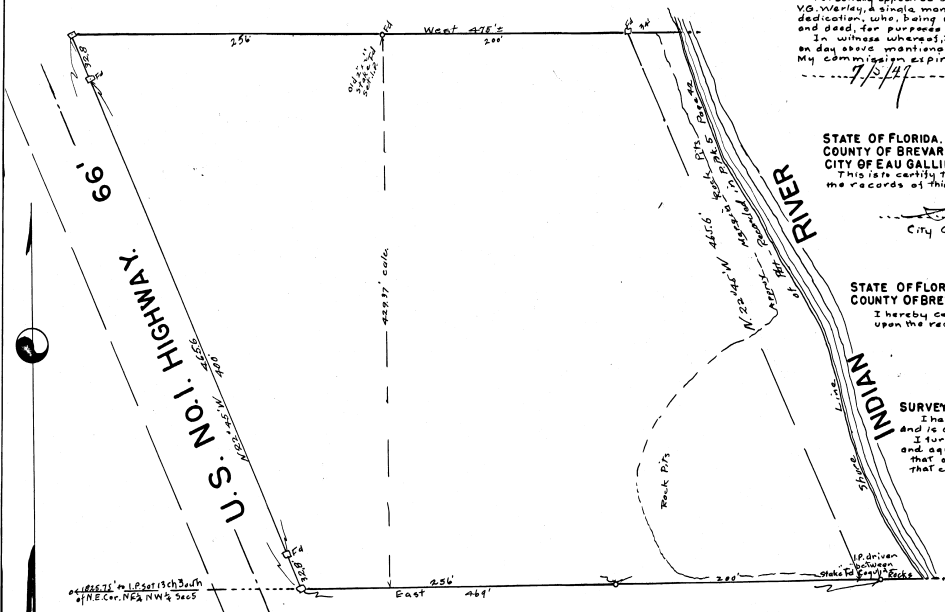


**MAP OF

Begin at a point on West bank of Indian River, 620 chains South of the North line Section 5, T. 27 S., R. 37 E. in Brevard Co., Florida thence due West, parallel to said Section line, a distance of 475 feet to a concrete post on East side of U.S. No. 1 Highway, thence S. 89° 15' W. along East side, said Highway, a distance of 487.5 feet to a concrete post, which post is 18.875 feet East of an iron pipe, 150 chains South of N.W. corner of NE 1/4 of NW 1/4, said Sec. 5, thence East and parallel to N. Line, said Sec. 5, a distance of 483 feet, more or less to the West Bank of Indian River thence Northwesterly along W. Bank of Indian River to point of beginning containing 4.5 Acres, more or less, together with Riparian Rights for Indian River.
