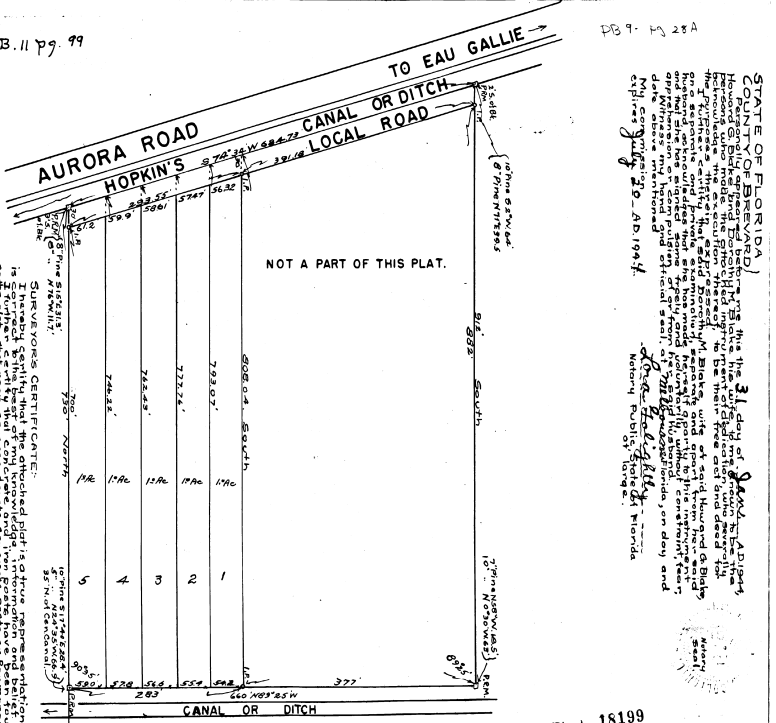

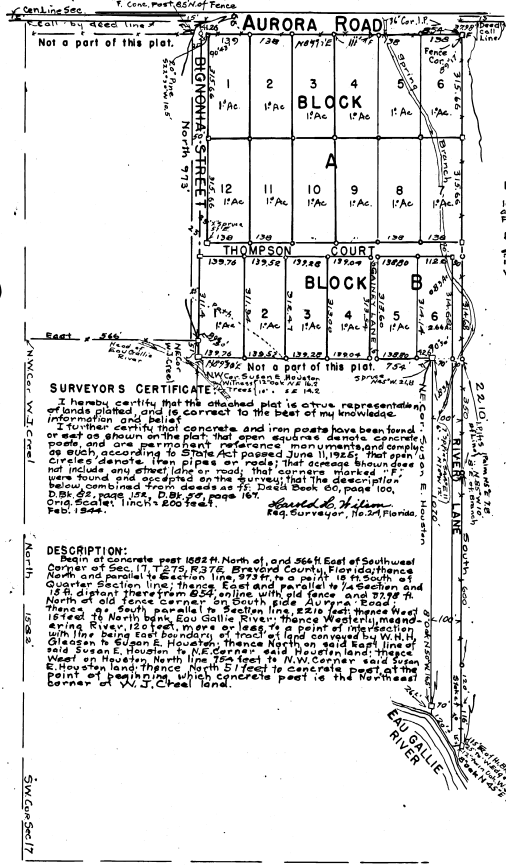
MAP OF BLAKE PLAT NO. 4
