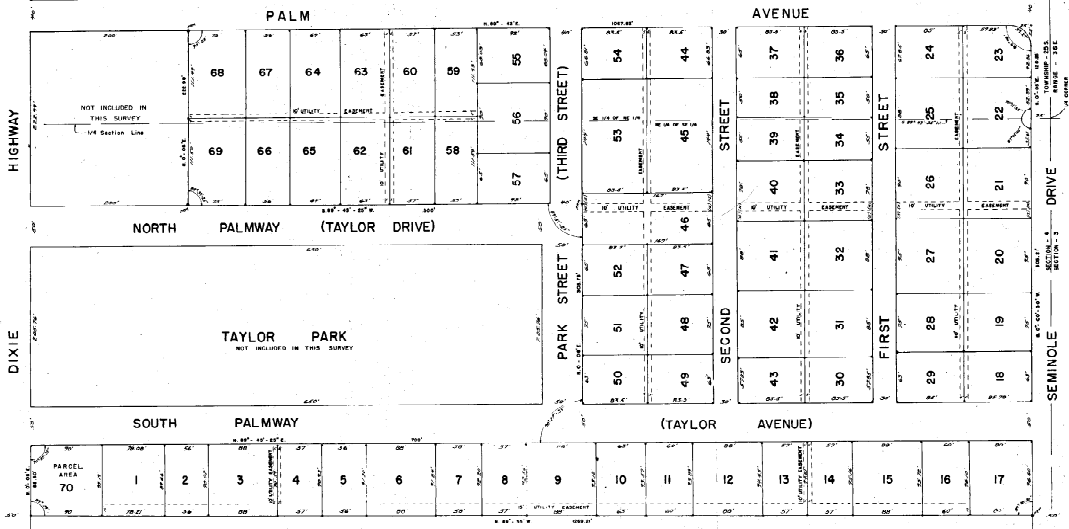

**NOTICE**

The United States of America, owner of the land in this Plat, acting by and through the Regional Director of Region 1, Rural Housing Administration, Rockledge and Home Finance Agency of the United States of America, hereby certifies that the map of Rockledge Homes, Project No. FL-012, located in Rockledge, Brevard County, Florida, and subject to the following restrictions, does hereby dedicate all streets, easements, utility easements and the water system and the appurtenances shown thereon to the City of Rockledge.

All streets, easements and other interests herein are subject to Section 4 (b) (1) of the Mobile Housing Act of 1942 (42 U.S.C. 1472) to be applicable to the construction of tractmobile housing contained in this subdivision. In effect in the event of any such construction, an interest covered for the use of the United States, together with the right of the United States through its authorized agents, or representatives, or any other person or persons, to acquire, use, occupy, lease, sell, lease, sublease, mortgage, convey, or otherwise dispose of the land, shall not be subject to any restriction or limitation of any kind, and the United States shall be held to be the owner of the land for all purposes.
