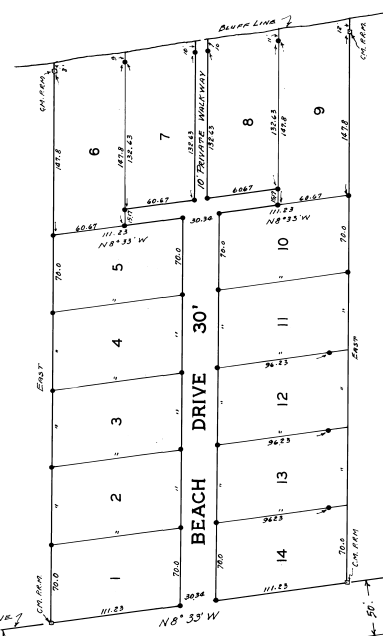


# CANAVERAL SHORES

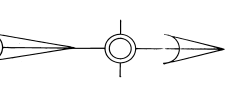

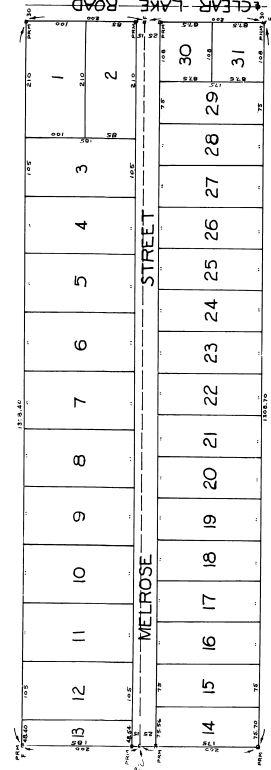
