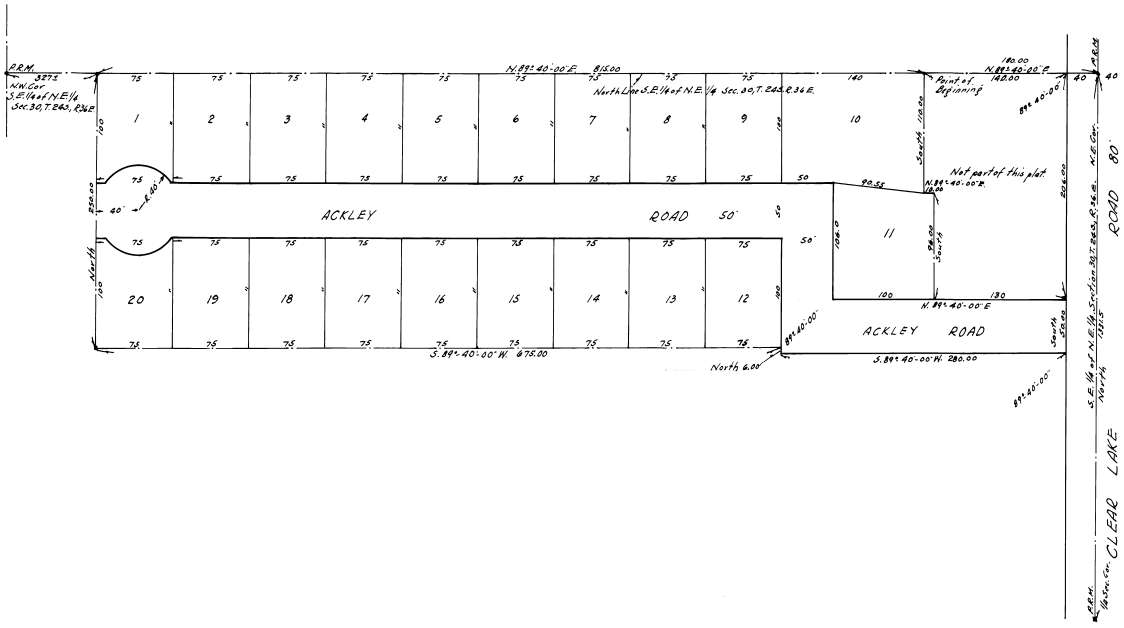


ACKLEY SUBDIVISION

A SUBDIVISION OF PART OF THE S.E. 1/4 of N.E. 1/4 SECTION 30, T. 24S, R. 36E,
BREVARD COUNTY, FLORIDA
Scale: 1" = 60' June 14, 1958

DESCRIPTION - Beginning at an iron pipe in the north line of the S.E. 1/4 of N.E. 1/4 of Section 30, T. 24S, R. 36E, which is 180.00 feet west of the northeast corner thereof; thence South 100.00 feet to an iron pipe; thence N. 89° 40' 00" E. and parallel to the said north line of the S.E. 1/4 of N.E. 1/4 of Section 30 a distance of 100.00 feet to an iron pipe; thence South and parallel to the east line of Section 30 a distance of 74.00 feet to an iron pipe; thence N. 89° 40' 00" E., 130.00 feet running parallel to the north line of the S.E. 1/4 of N.E. 1/4 of Section 30 to an iron pipe in the west line of the 50-foot right-of-way of Clear Lake Road; thence South along said right-of-way line 50.00 feet to an iron pipe; thence S. 89° 40' 00" W. 280.00 feet to an iron pipe; thence North 6.00 feet to an iron pipe; thence S. 89° 40' 00" W. 475.00 feet to an iron pipe; thence North 250.00 feet to an iron pipe at the intersection north line of the S.E. 1/4 of N.E. 1/4 of Section 30; thence N. 89° 40' 00" E. 815.00 feet to the point of beginning and containing 4.88 acres of land.
