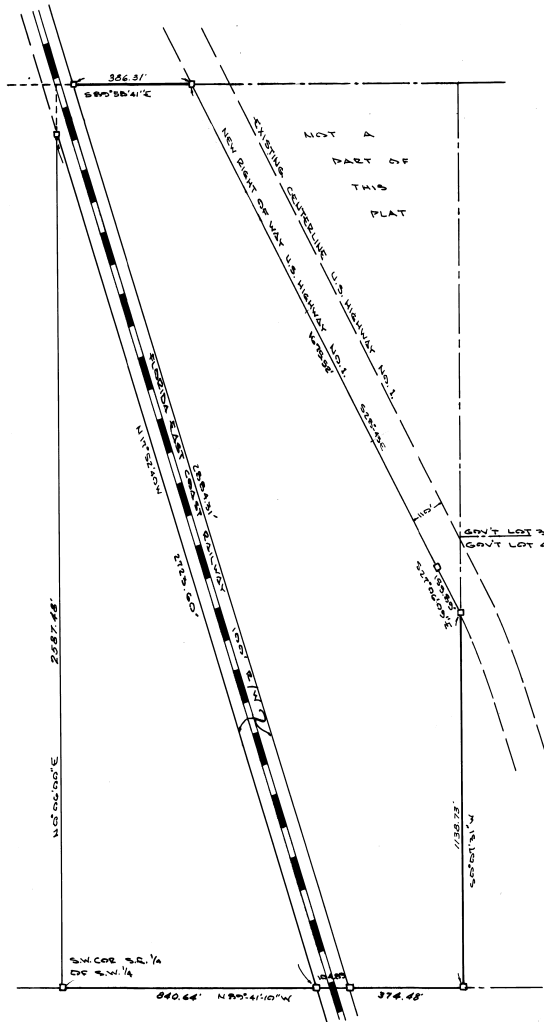


FLORIDA MEMORIAL CEMETERY

THE EAST 1/2 OF THE S.W. 1/4, LESS EIGHT OF WAY FOR FLORIDA EAST COAST RAILROAD AND LESS EIGHT OF WAY FOR U.S. HIGHWAY NO. 1 AND LESS THAT PART OF SAID EAST 1/2 OF S.W. 1/4 LYING EAST OF EAST RIGHT OF WAY OF SAID U.S. HIGHWAY NO. 1, SECTION 1, TOWNSHIP 26 SOUTH, RANGE 36 EAST, TALLAHASSEE MEMORIAL, BREVARD COUNTY, FLORIDA.
