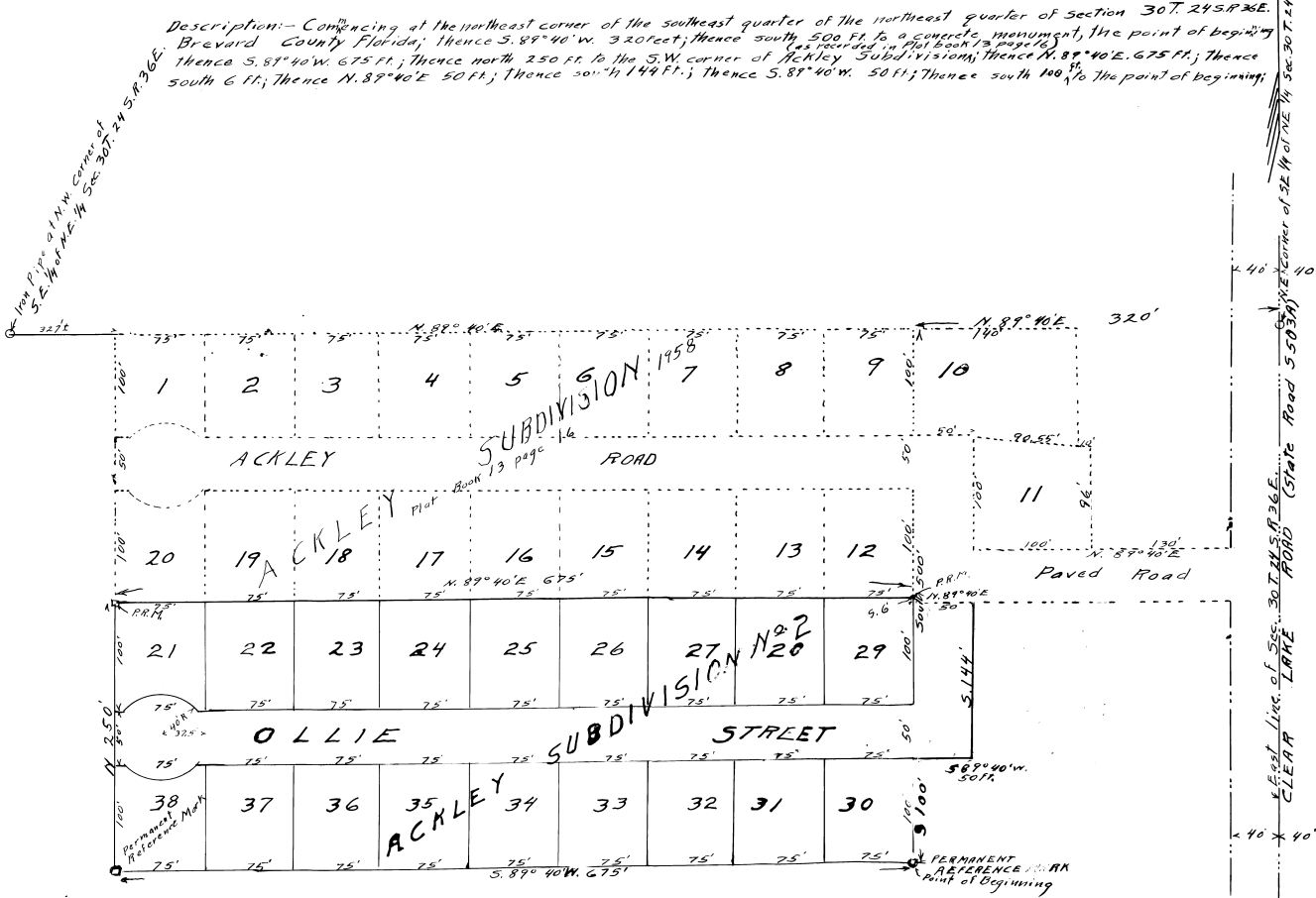


ACKLEY SUBDIVISION No 2

Brevard County Florida; thence S. 89° 40' W. 320 feet; thence south 500 Ft. to a concrete monument, the point of beginning; thence S. 81° 40' W. 675 Ft.; thence north 250 Ft. to the S.W. corner of Ackley Subdivision; thence N. 89° 40' E. 675 Ft.; thence south 6 Ft.; thence N. 89° 40' E. 50 Ft.; thence 50' 1/4" 149 Ft.; thence S. 81° 40' W. 50 Ft.; thence south 100' to the point of beginning;
