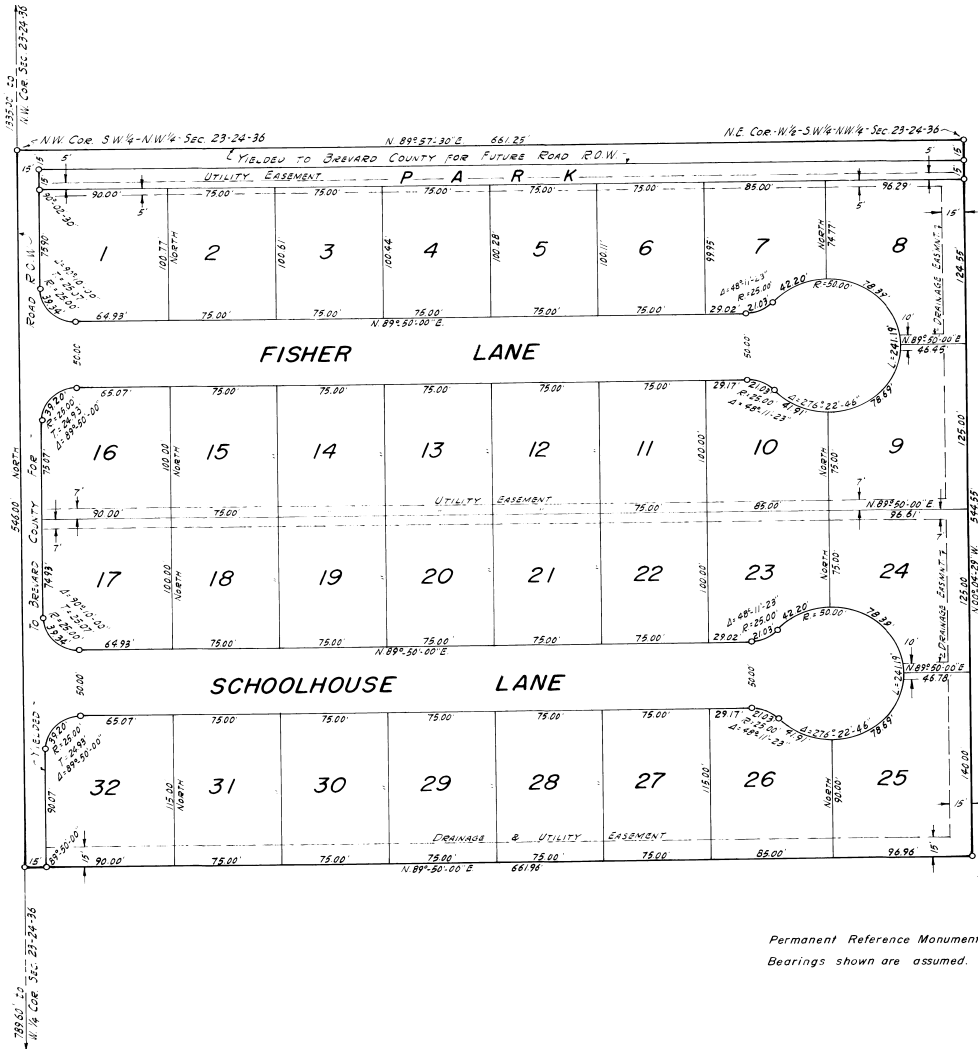


MERRITT ISLAND VILLAGE
