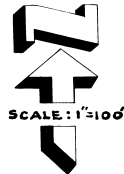
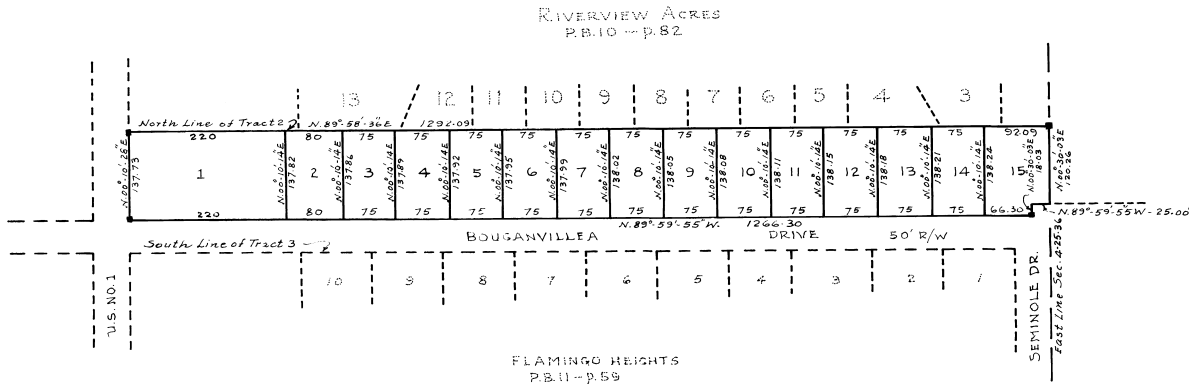


# MAYFIELD SUBDIVISION
