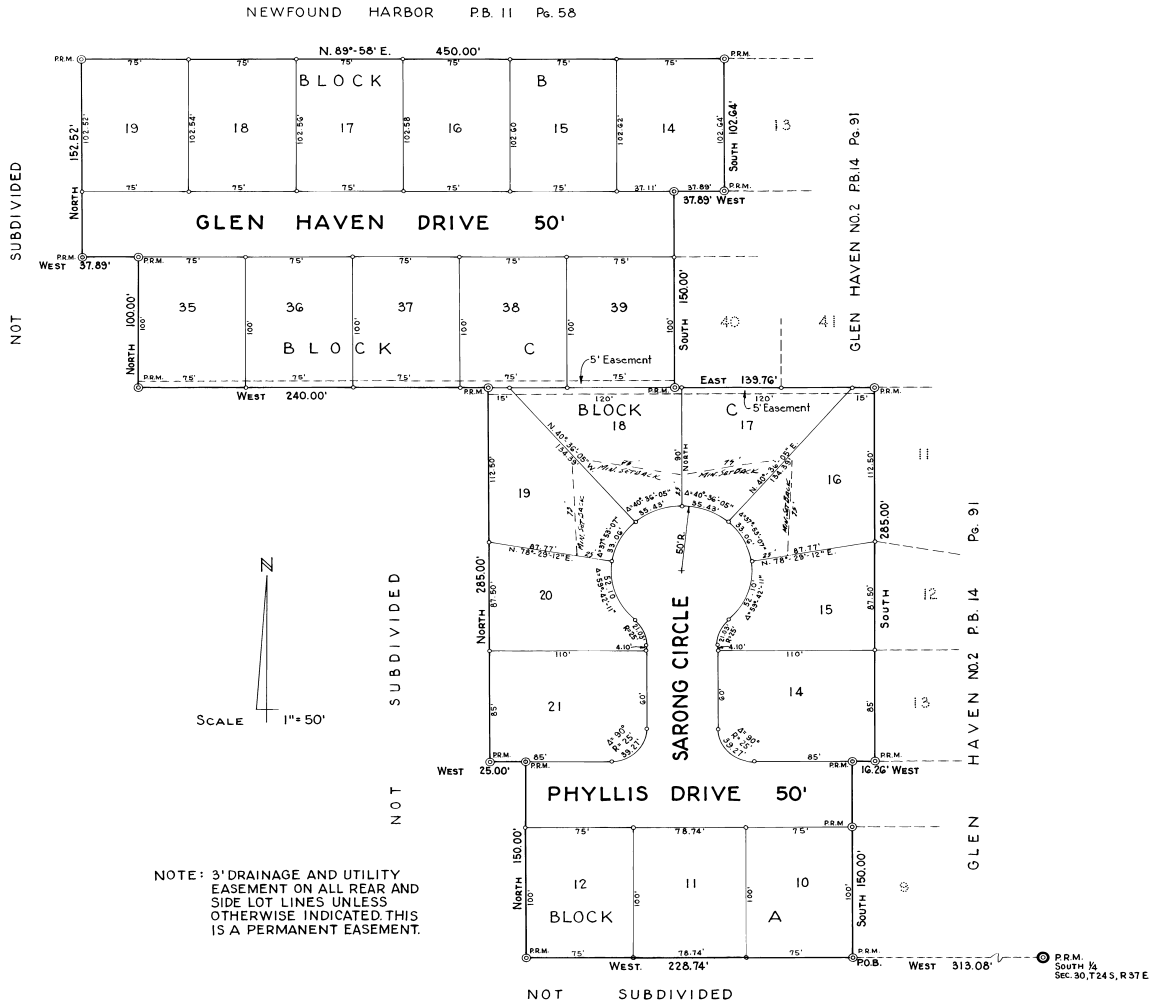


GLEN HAVEN SUBDIVISION-SEC.2A
