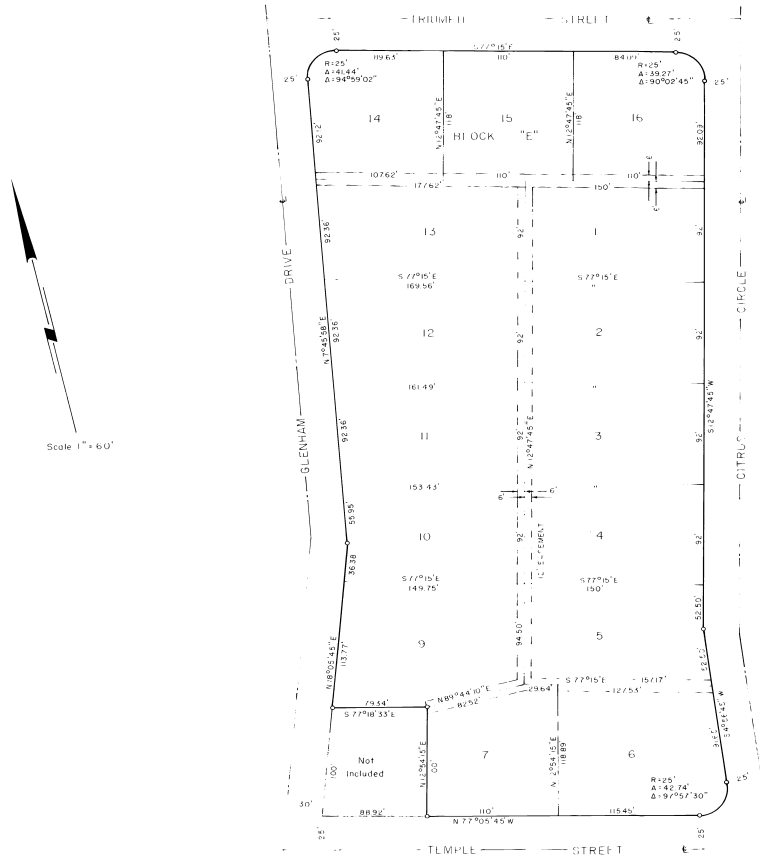


# REPLAT OF BLOCK "E", HIGHLAND SHORES ESTATES
