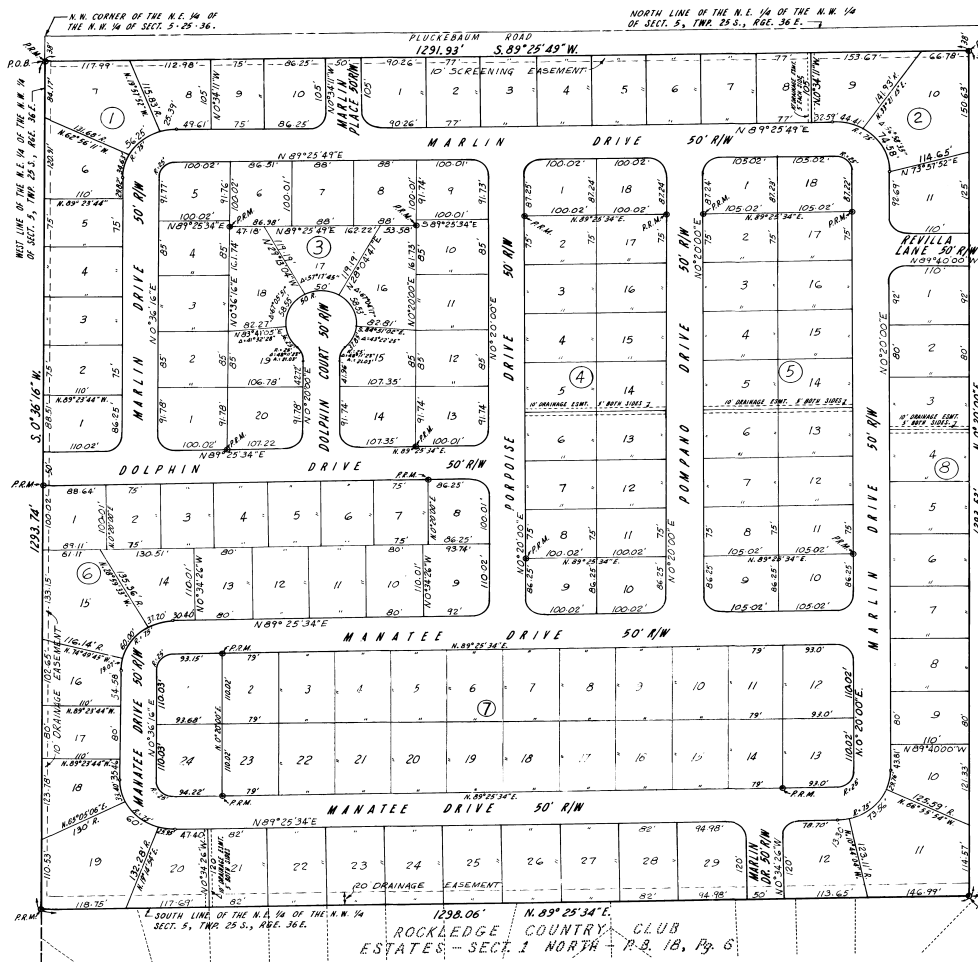
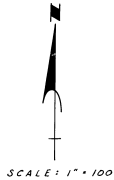


MARLIN SUBDIVISION

DESCRIPTION

A Portion of the NE 1/4 of the NW 1/4 of Section 5, Township 25 South, Range 36 East, Brevard County, Florida, being more particularly described as follows:

Commence at the NW corner of the said NE 1/4 of the NW 1/4 of Section 5; thence S. 0° 36' 16" W. along the West line of the said NE 1/4 of the NW 1/4 of Section 5 a distance of 380.0 feet to the point of beginning; thence continue S. 0° 36' 16" W. along the last described course a distance of 1293.74 feet; thence N. 89° 25' 34" E. along the South line of the said NE 1/4 of the NW 1/4 of Section 5 a distance of 1293.06 feet; thence N. 0° 20' 00" E. and parallel to the East line of the said NE 1/4 of the NW 1/4 of Section 5 a distance of 1293.53 feet to a point on the South right-of-way of Pluckebaum Road; thence S. 89° 25' 34" W. along the said South right-of-way of Pluckebaum Road and parallel to the North line of the NE 1/4 of the NW 1/4 of Section 5 a distance of 1291.93 feet to the point of beginning.
