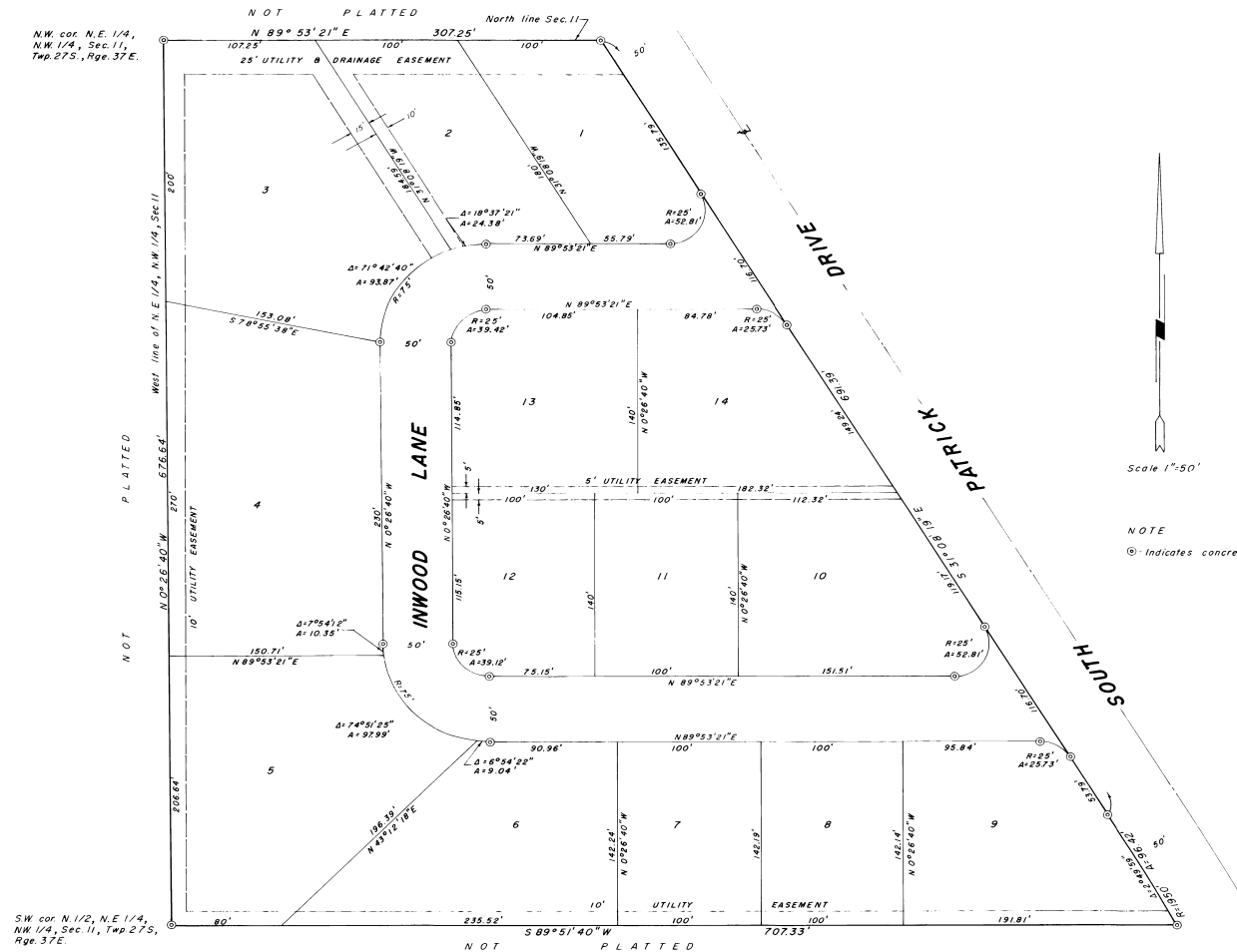


INWOOD ISLES SUBDIVISION
