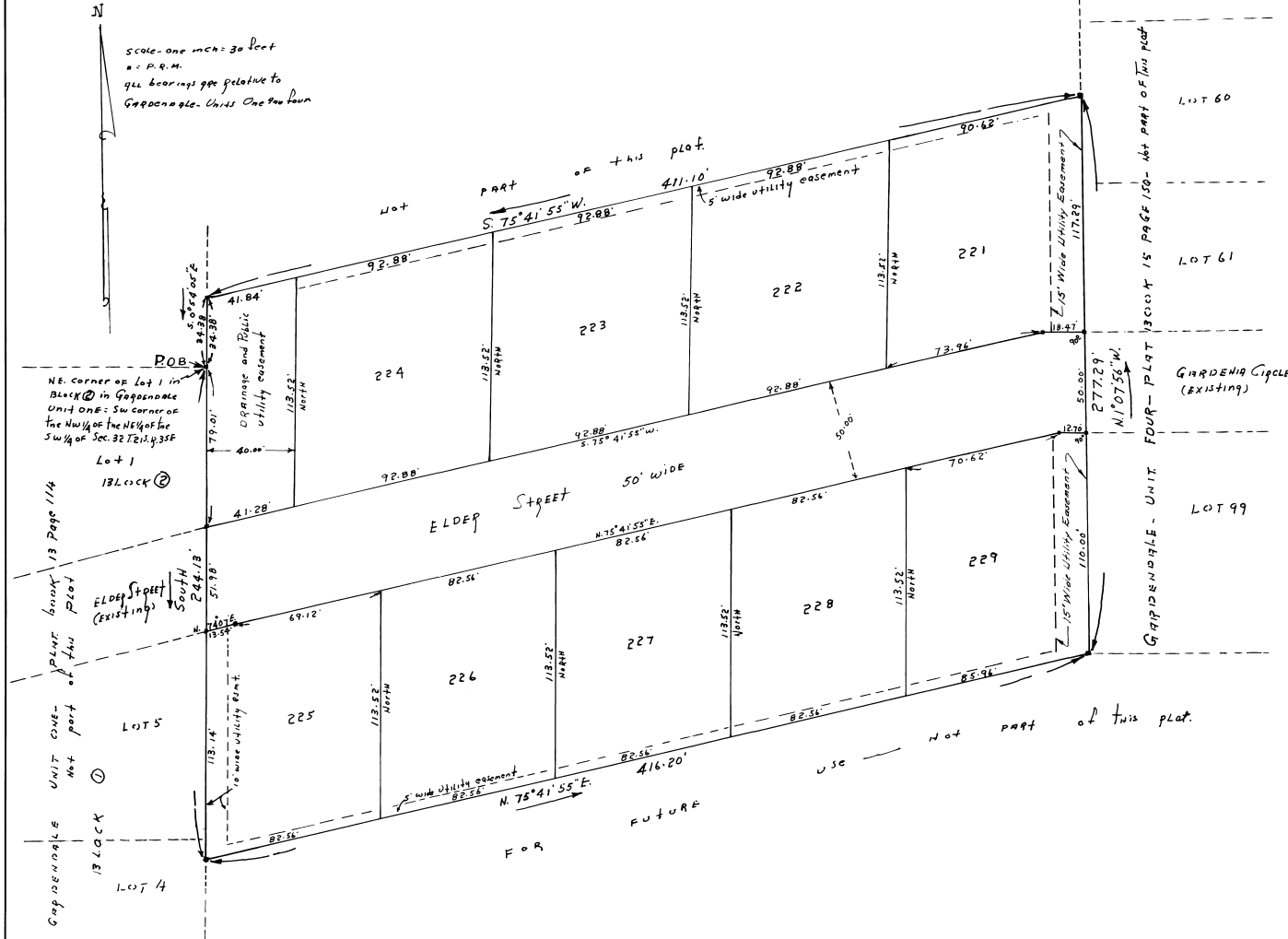


GARDENDALE UNIT TEN

SITUATE IN THE S.W. 1/4 OF SECTION 32-TWP 21 S.-R. 35 E., BREVARD CO.-FLA. More PARTICULARLY described as follows to wit: Begin at the S.W. corner of the N.W. 1/4 of the NE 1/4 of the S.W. 1/4 of Section 32. T. 21 S. R. 35 E., Said P.O.B. is also the N.E. corner of Lot 1 in Block 13 in GARDENDALE UNIT ONE (plat book 13, p. 114) proceed thence from said P.O.B. along the East boundary of said Gardendale Unit One South a distance of 244.13 feet thence N. 75° 41' 55" E., 416.20' to the S.W. corner of Lot 99 in Gardendale Unit Four (plat book 15, p. 150) thence along the West boundary of said Gardendale Unit Four, N. 107° 56' W. 277.29 feet thence S. 75° 41' 55" W. 411.10' to a point in the West boundary of said NW 1/4 of the NE 1/4 of the S.W. 1/4 of Sec. 32 thence along said West boundary S. 05° 40' E., 34.38 feet to the point of beginning.
