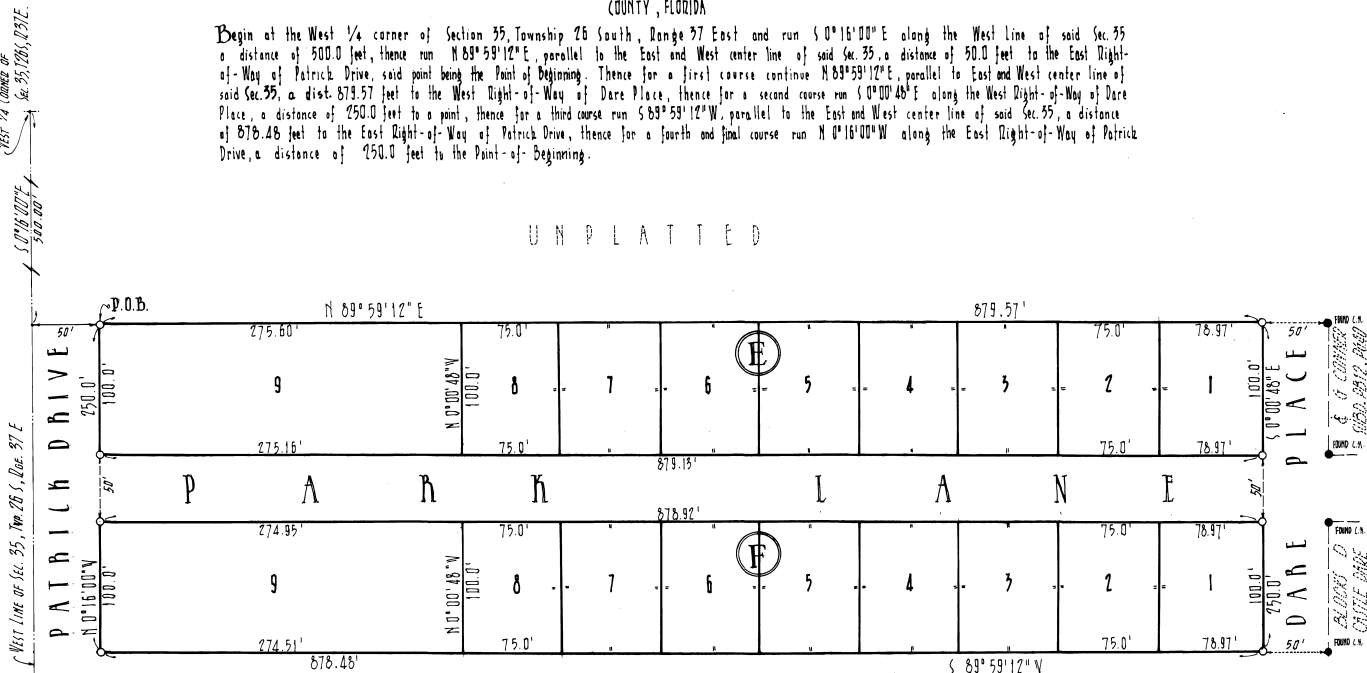


REPLAT of BLOCKS E and F (CONNOR'S) CASTLE DADE SUBDIVISION

BEING A REPLAT OF BLOCKS E and F OF CONNOR'S CASTLE DADE SUBDIVISION AS RECORDED IN PLAT BOOK 12, PAGE 40 OF THE PUBLIC RECORDS OF BREVARD COUNTY, FLORIDA

Begin at the West 1/4 corner of Section 35, Township 26 South, Range 37 East and run S 0° 16' 00" E along the West line of said Sec. 35 a distance of 500.0 feet, thence run N 89° 59' 12" E, parallel to the East and West center line of said Sec. 35, a distance of 50.0 feet to the East Right-of-Way of Patrick Drive, said point being the Point of Beginning. Thence for a first course continue N 89° 59' 12" E, parallel to East and West center line of said Sec. 35, a dist. 879.57 feet to the West Right-of-Way of Dade Place, thence for a second course run S 0° 00' 46" E along the West Right-of-Way of Dade Place, a distance of 250.0 feet to a point, thence for a third course run S 89° 59' 12" W, parallel to the East and West center line of said Sec. 35, a distance of 878.46 feet to the East Right-of-Way of Patrick Drive, thence for a fourth and final course run N 0° 16' 00" W along the East Right-of-Way of Patrick Drive, a distance of 250.0 feet to the Point-of-Beginning.

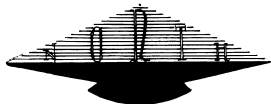
