

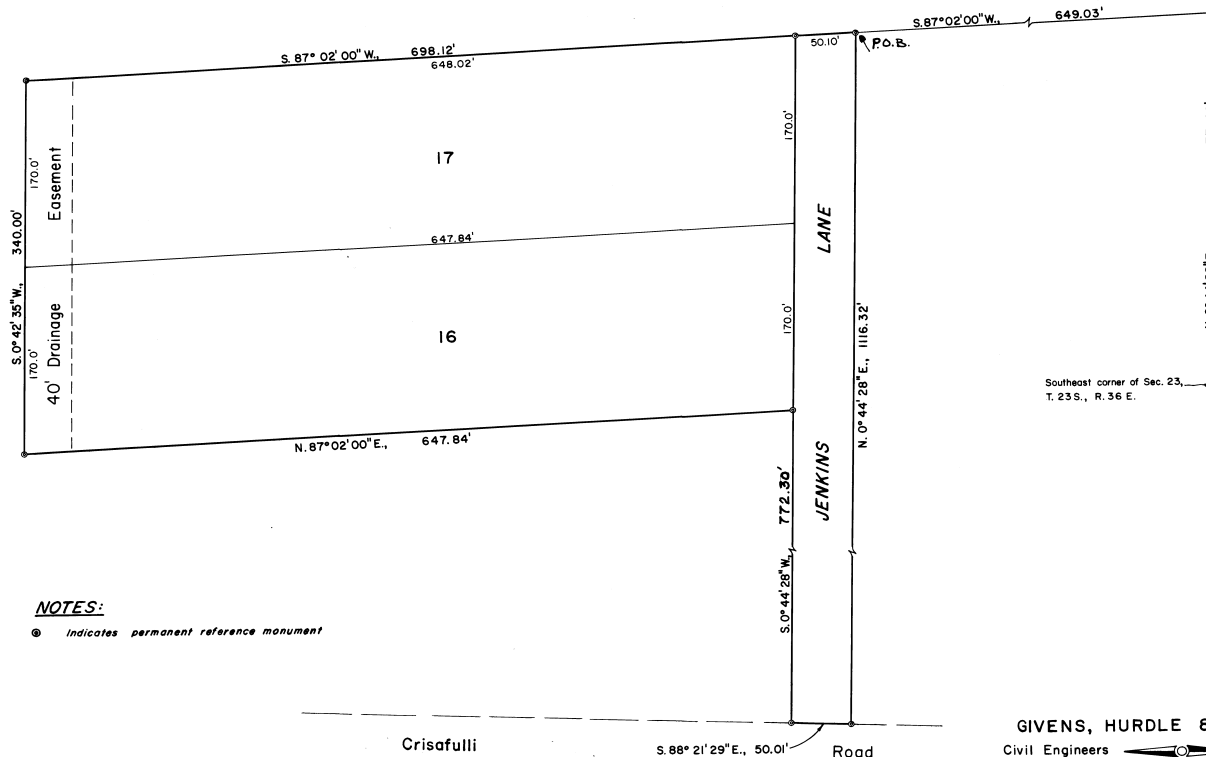
Jenkins Acres

DESCRIPTION

From the Southeast corner of Section 23, Township 23 South, Range 36 East, Brevard County, Florida, run $N00^{\circ}44'28''E.$ along the East line of said Section, a distance of 1771.22 feet; thence run $S.87^{\circ}02'00''W.$ 649.03 feet to the Point-of-Beginning; thence continue $S.87^{\circ}02'00''W.$ 698.12 feet; thence run $S.00^{\circ}42'35''W.$ 340.00 feet; thence run $N.87^{\circ}02'00''E.$ 647.84 feet; thence run $S.00^{\circ}44'28''W.$ 772.30 feet; thence run $S.88^{\circ}21'29''E.$ 50.01 feet; thence run $N.00^{\circ}44'28''E.$ 1116.32 feet to the Point-of-Beginning, containing 6.32 acres more or less.
