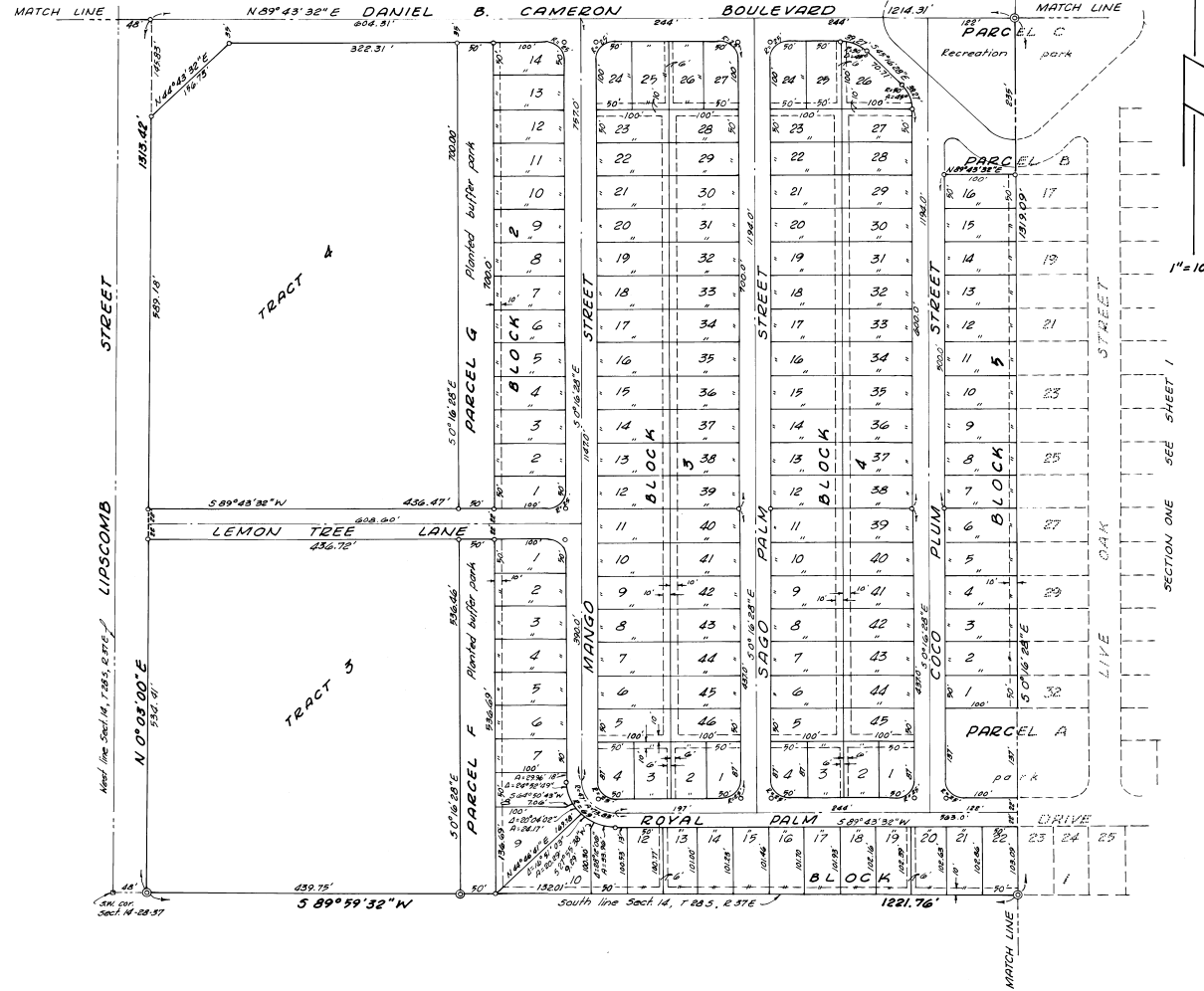
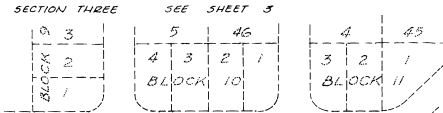
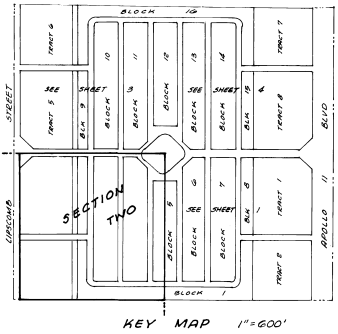


PALM BAY COLONY SECTION TWO
