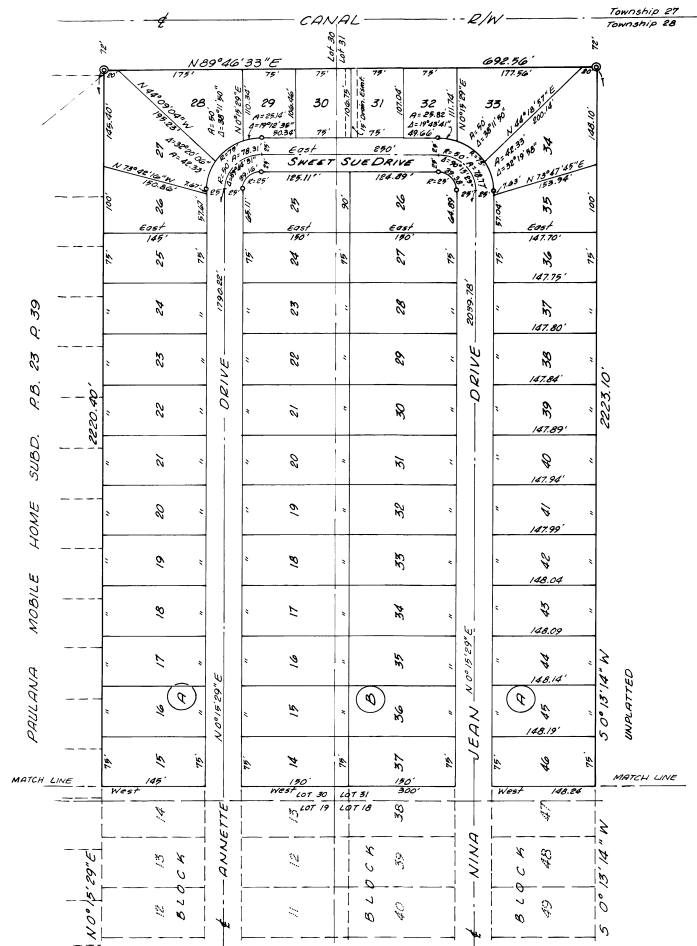
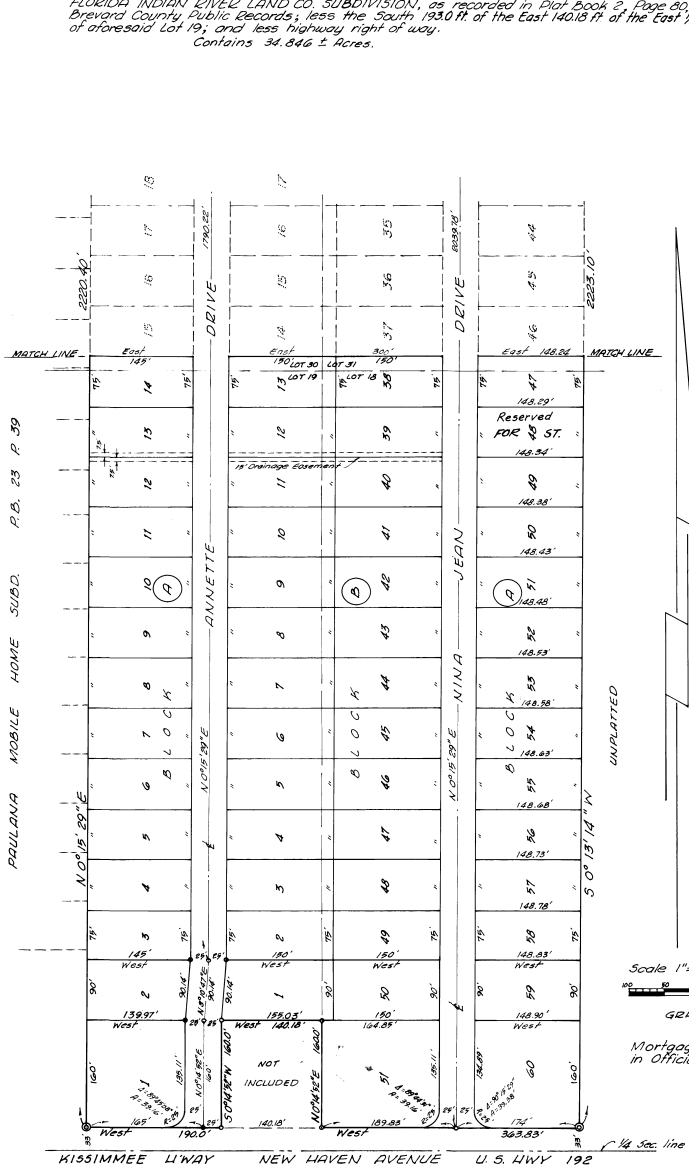


PAULANA EAST
