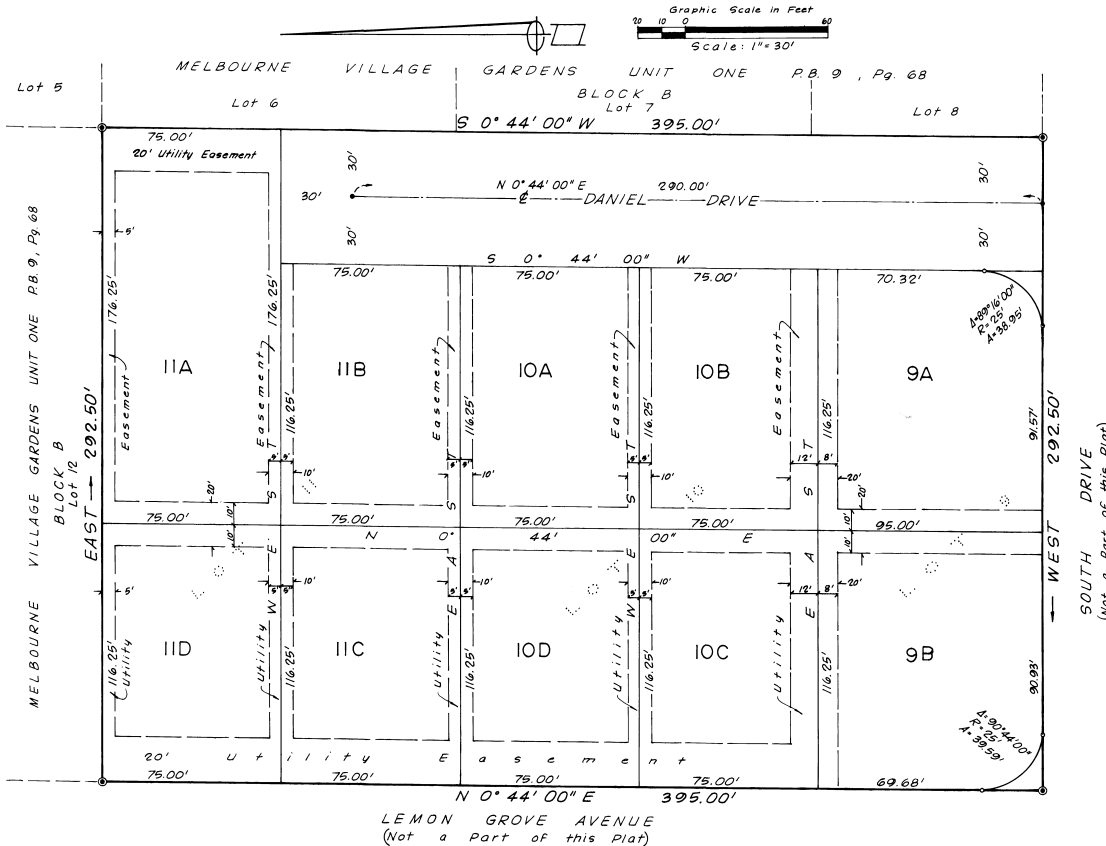


**A RE-SUBDIVISION OF LOTS 9, 10 & 11, BLOCK B,
