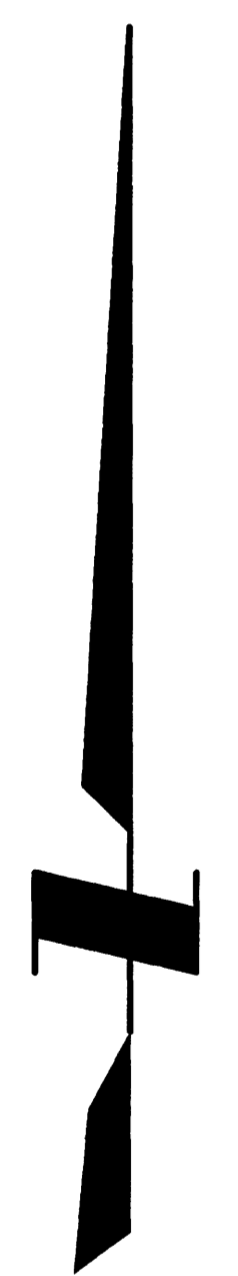


# LAUREL RUN AT MEADOWRIDGE - PHASE ONE

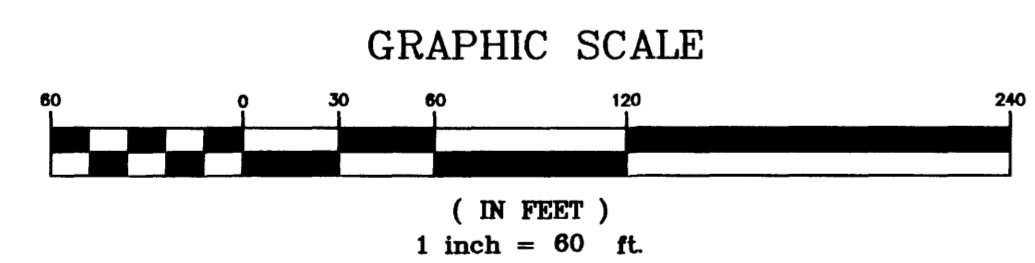
